As reported in the 2015/2016 submission, the Diversity Committee and Diversity Champions have continued to bring focus across the Group to our 3 key diversity initiatives:

1. Gender balance across all levels, 2. Flexible working initiatives and 3. Cultural diversity and awareness.

Over the past 12 months our 3 key diversity themes have been addressed through the following new initiatives:

- Introduction of the Enero Women program. The program connects senior female leaders in various ways, including through networking groups, groups sessions with influential guest speakers, mentor/mentee program, coaching and leadership development.
- Manager training to provide them with a toolkit with which to manage their staff effectively.
- Family, domestic and sexual violence policy launched with a strong support position for employee victims. Additional training added to Manager and employee training programs.
- Hire of a position through a disability employment service

Other initiatives have also been continued throughout the last 12 months:

- Celebrating company and team diversity through a celebration of food from each employee's cultural background – international food day.
- International Women's Day – for this year's theme 'Be Bold for Change' we focused on barriers to females advancing into executive positions.
