

## Notice Pursuant to Section 708A(5)(e) of the Corporations Act 2001 (Cth)

Enero Group Limited (ASX: EGG) (**Enero**) gives notice under section 708A(5)(e) of the *Corporations Act* 2001 (Cth) (**Act**) as follows:
